Comes the Plaintiff, David B. Mour, and for his Complaint against the Defendant, Kendrick L. Wilson, states as follows:

1. Plaintiff, David B. Mour is a resident of Kentucky residing in Jefferson County and is an attorney licensed to practice in the Commonwealth of Kentucky in good standing, and he has been in and continued in good standing since his admission to the practice of law in Kentucky in April of 1986.
2. Plaintiff has been actively involved in the civil rights movement in Louisville, Kentucky, since its resurgence in late May of 2020, said involvement including, but not necessarily being limited to representing numerous protestors falsely arrested by local law enforcement, as well as providing legal advice and representation to one or more civil rights groups.
3. Defendant, Kendrick L. Wilson ("Wilson"), is a resident of Kentucky.

4. The damages complained of herein exceed the minimum amount necessary to establish the jurisdiction of this Court and in addition, Plaintiff seeks injunctive relief, temporary and permanent.

5. On numerous occasions on and after January 31, 2021, Wilson has uttered, published transmitted and broadcast through social media platforms, and otherwise, including but not limited to Facebook's "*Livestream*" feature, false and defamatory statements regarding Plaintiff, which false and defamatory statements were spoken and written and were received and observed by numerous persons residing in Jefferson County.

6. The false and defamatory statements uttered by Wilson regarding Plaintiff constitute slander and/or libel *per se* and include, but are not necessarily limited to the following:

- a. Statements that, or to the effect that, Plaintiff is a criminal or has engaged in criminal activity;
- b. Statements that, or to the effect that, Plaintiff is a thief;
- c. Statements suggesting or claiming that Plaintiff is engaged in human trafficking and specifically, that he is involved in the sale and/or trafficking of children;
- d. Statements to the effect that Plaintiff owes and/or was forced to pay millions of dollars to third parties due to judgments having been entered against him;
- e. Statements suggesting or claiming that Plaintiff is dishonest generally, and in connection with events that have occurred in the civil rights movement in Louisville, even going so far as to claim that Plaintiff's minor daughter, who is also involved in the civil rights movement has lied about certain events;

- f. Statements claiming that Plaintiff had an ownership interest in a trucking company which was engaged in human trafficking and/or other unlawful activity;
- g. Statements claiming Plaintiff was involved in or with one or more other companies, individuals or real properties engaged or involved in human trafficking and/or other unlawful activity;

7. On information and belief, even prior to January 31, 2021, Wilson had published statements or information regarding Plaintiff of the type set forth in the prior paragraph which which were false and defamatory, and/or portrayed Plaintiff in a false light.

8. Wilson knew or should have known the false and defamatory statements he published regarding Plaintiff were in fact false, untrue, misleading and/or inaccurate and his utterance and publication of said statements was undertaken intentionally, wilfully and with actual malice by Wilson with the express purpose and goal of damaging Plaintiff's reputation, which statements have in fact damaged Plaintiff's reputation, both personally and professionally.

9. In addition to the above, Wilson has published and disseminated information and statements repeatedly designed to portray Plaintiff in a false light, both before, on and after January 31, 2021.

10. Wilson's conduct in defaming Plaintiff and portraying him in a false light is part and parcel of a pattern and practice engaged in by Wilson, with the assistance of other unknown individuals, wherein he targets, harasses, bullies, intimidates, threatens and defames various other individuals involved in the civil rights movement, including but not limited to Plaintiff. Indeed, Plaintiff has learned that on February 4, 2021, another individual who was targeted by Wilson obtained a civil restraining order against him in the Jefferson District Court requiring

Wilson to cease and desist such conduct regarding said individual, which restraining order, on information and belief, Wilson has already violated.

11. On or about January 31, 2021, Plaintiff transmitted a written communication to Wilson demanding he immediately cease and desist publishing any further false and/or defamatory statements or information regarding Plaintiff and that he cease portraying Plaintiff in a false light.

12. Wilson's response to Plaintiff's directive to cease and desist as above described was to advise Plaintiff "F\*\*\* you eat a d\*\*k". In addition Wilson immediately turned to social media to resume his false and defamatory attacks on Plaintiff as well as others

13. In addition, on information and belief, after initially receiving Plaintiff's directive to cease and desist, Wilson deleted some of his videos from social media in an apparent effort to conceal and/or eliminate proof of his defamatory and actionable conduct.

#### **COUNT I-DEFAMATION/PORTRAYAL IN FALSE LIGHT**

14. All prior paragraphs are herein restated and reiterated.

15. The aforementioned conduct of Wilson constitutes actionable portrayal of Plaintiff in a false light and defamation of character, specifically, in the form of both slander and libel *per se*, entitling Plaintiff to an award of damages against Wilson, presumed and actual.

16. Regarding Plaintiff's presumed damages, based on *per se* defamation, said award against Wilson should be not less than one millions dollars (\$1,000,000.00)

17. In addition, Wilson's aforementioned conduct was undertaken with actual malice and was intentionally designed to injure and harm Plaintiff, and based thereon, Plaintiff is also entitled to an award of punitive damages.

**COUNT II- INJUNCTIVE RELIEF TEMPORARY AND PERMANENT**

18. All prior paragraphs are herein restated and reiterated.

19. The aforementioned conduct on the part of Wilson has caused, and if allowed to continue, is causing and will continue to cause Plaintiff irreparable harm in the form of continued and further damage to his personal and professional reputation, which damage cannot be measured or compensated via money damages.

20. Accordingly, Plaintiff is entitled to injunctive relief in the form of entry of an Order banning or restricting Wilson from using or employing social media for any purpose, or in the alternative, banning Wilson from mentioning or discussing Plaintiff on social media or in any other forum or medium, either directly or indirectly.

WHEREFORE, Plaintiff demands relief as follows:

A. Entry of a money judgment against Wilson to compensate Plaintiff for his damages, presumed in an amount not less than One Million Dollars (\$1,000,000.00), and actual, along with an award of punitive damages, in an amount deemed fair and just by the trier of fact, with interest thereon at the maximum legal rate for the maximum duration allowed by law.

B. Entry of a temporary and permanent injunction as above set forth to prevent Wilson from further defaming Plaintiff and/or portraying him in a false light.

C. Trial by jury on all issues so triable.

D. His costs herein incurred including attorney fees.

E. Any and all other relief to which he may be entitled.
